SCOPE OF WORK DIVISION OF NATURAL RESOURCES BOATING, FISHING, & NON-FEDERAL PUBLIC STREAM ACCESS SITES 2023

- Maintenance activities include the mowing of grass and other non-woody vegetation, trash pickup, removal of debris from the boat ramp, and a general maintenance associated with the boating access sites.
 - Complete the following inside the site perimeter and within 3 feet outside the perimeter of the access and road:
 - i. Pick up trash
 - ii. Cut weeds and grass
 - iii. Clear brush around signs
- 2. Properly dispose of trash*, weeds, and grass
- 3. Please use the CRP-specific Sportsman Access Maintenance Form as a reference to ensure all signage is in place and all activities have been completed.
- 4. If an issue is found (missing signage, excessive trash, etc), please fill out the Sportsman Access Maintenance Form, take a picture (if possible) of the problem, and report the problem to the proper parties. Issues may include, not are not limited, to:
 - Missing or damaged signs
 - Irregular road conditions/site conditions (ramps, lots, etc)
 - Evidence of open fires and/or illegal activities noticed
 - Site used as a dump site (See specific instructions below)
- 5. Visit the sites as outlined in the attached subsequent documents for locations covered within this scope of work:
 - 2023 Stream Access Boating Sites Pricing Sheet (Exhibit I)
 - 2023 Stream Access Fishing Sites Pricing Sheet (Exhibit I)
